Bidders should deposit the equivalent fee for bidding document in the above Revenue Account within the date and time specified above. Bids submitted in hardcopy for NCB contract shall not be accepted.
- 3. A new firm established by any person or manager of a firm or company that is blacklisted according will be ineligible to submit bids.
- 4. Bidders shall deposit the Bid Document Fee on the respective Bank A/C including name of Firm and Contract ID in bank deposit slip. Bidders can also deposit the Bid Document Fee on the Account Section of Bagmati Rural Municipality Office located at Bhattedanda Lalitpur. In that such case Bidders shall upload the revenue receipt instead of bank voucher.
